

## Manager - Security Management

As **Manager – Security Management**, you'll be responsible for directing and managing all aspects of day-to-day physical security operations, as well as planning, developing and implementing new physical security enhancements, standards, infrastructure revitalization and replacements to address current and future needs. A vital aspect of your role will involve managing and ensuring the maintenance and revitalization of physical security to meet the current and future needs of the organization, including the development of processes and best practices in accordance with current municipal, provincial and federal regulatory standards.

## **RESPONSIBILITIES**

As Manager of Security Management, you'll:

- Direct and manage a team of technical, administrative and contracted staff in the planning, coordination and delivery of daily physical security operations.
- Plan, develop and implement staff training and development opportunities, establish performance standards and conduct performance evaluations.
- Provide direct input into hiring decisions and be accountable for overall team results.
- Develop and implement construction/design standards as it relates to physical security, e.g.
  master specifications, product and/or materials, design briefs, security standards, project closeout, commissioning and hand-over policies and procedures, etc., in order to clearly define
  requirements and further provide accurate, up-to-date information to contractors, specialists,
  corporate stakeholders and staff.
- Manage the attainment of short- and long-term strategic planning priorities, goals and
  objectives assigned to the area, through the direct provision of services by incumbent staff
  and/or through the coordination and delivery of externally procured services.
- Provide administrative direction, and advice and support to staff on all physical security-related issues, programs and initiatives.
- Conduct regular physical security assessments related to the ongoing lifecycle of related equipment.
- Develop and manage the area's current operating and/or capital budgets in accordance with approved levels of funding.
- Assist the Chief's Management Group and senior staff by providing expert advice and guidance on physical security-related issues, including long- and short-term planning, contract administration and operational initiatives and programs.
- Review, and comment on, a variety of physical security and security management-related information for the purpose of accuracy and completeness (e.g. construction documents and contracts, CCDC, bonding, etc.).

- Manage the procurement of all physical security-related infrastructure and service contracts in accordance with all relevant legal, risk management and purchasing requirements.
- Participate on internal and external committees representing the department and organization on physical security-related issues, and network with external organizations and other experts in the field to exchange information and maintain awareness of trends and new business strategies.
- Ensure compliance with municipal, provincial and federal regulatory standards pertaining to the management and operation of public facilities.

- A university degree in Engineering or a related field, or an equivalent combination of education and experience.
- Crime Prevention through Environmental Design (CPTED/CPD) and/or Physical Security Professional (PSP) certification(s).
- A minimum of five (5) years of experience managing corporate physical security, including developing short- and long-term strategic facilities physical security plans and associated Capital Plans, e.g. security systems revitalization and replacement.
- Demonstrated managerial and supervisory skills.
- Demonstrated planning, time management and organizational skills.
- Demonstrated project management skills.
- Effective oral communication and interpersonal skills.
- Demonstrated written communication skills.
- Well-developed analytical and problem-solving skills.
- Demonstrated strategic thinking and a broad awareness of current trends and developments in related fields.
- Familiarity with applicable building and safety codes and regulations.
- A working knowledge of recognized trades.
- A valid Ontario Driver's Licence (Class G) with full driving privileges.
